- Extra point for fire extinguisher

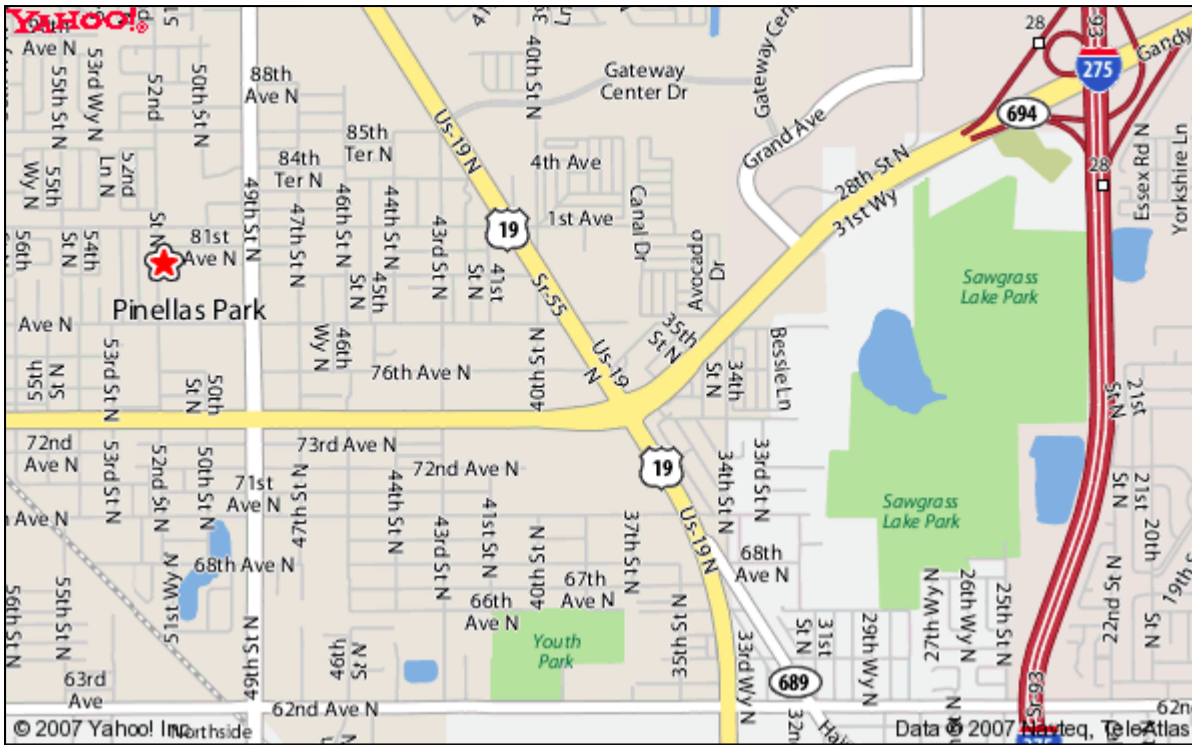
